

# THIS LAND IS OUR LAND

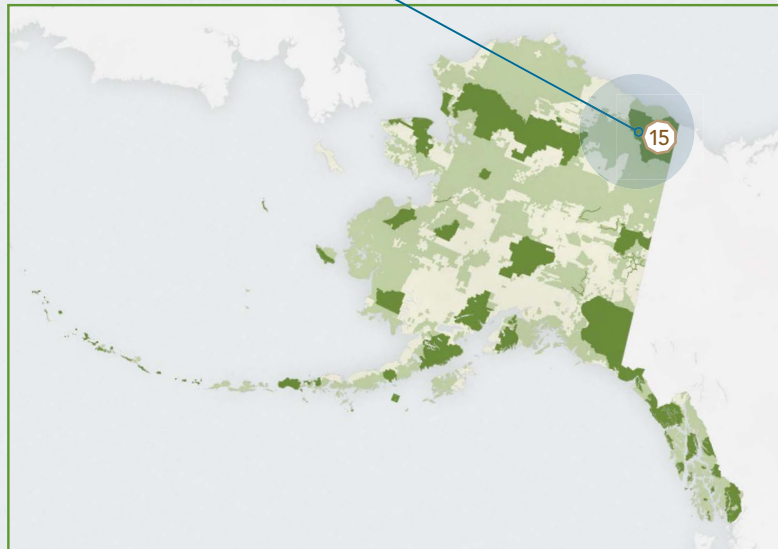

Protecting key forests and headwaters and enhancing recreational access for people from all backgrounds

**NORTHERN ROCKIES**  
Defending and connecting the 60-million-acre ecosystem between the Crown of the Continent, Greater Yellowstone Ecosystem, and Idaho's High Divide

**NORTHERN NEW ENGLAND FORESTS**  
Defending critical wildlife habitat and recreation opportunities that span the Appalachian Trail

**SOUTHERN APPALACHIANS**  
Protecting the remaining biodiverse eastern temperate forests and creating sustainable recreation opportunities

**GREAT BASIN**  
Defending some of our nation's newest national monuments and protecting wildlife habitat at a landscape scale

**COLORADO RIVER WATERSHED**  
Defending national monuments and irreplaceable Native American cultural resources

**RIO GRANDE WATERSHED**  
Protecting the ecologically significant wildlands that sustain New Mexico's diverse communities
